


#### Poland

### TODAY

**SOITRON GROUP** currently operates on the European market as one of the largest infocommunication integrators and IT service providers with more than 820 employees. The philosophy to progress continuously, has made Soitron Group a leader in introducing unique technologies and innovative solutions. The company generated a revenue of more than EUR 181 million in 2023.



### 2020~2023

Since 2020 major investments were made into IT and OT cybersecurity solutions. Building on a strong footprint, we have expanded our portfolio, vendors, expertise, certifications, and customer projects. The cybersecurity team operates in Slovakia, the Czech Republic, Romania, and Turkey, and it has a presence in Poland and Bulgaria. A SECURITY **OPERATIONS CENTRE - VOID SOC** was founded within Soitron Group.

At the Turkish market, we have spinned-off the cybersecurity company SOITRON from SEKOM. Both companies now represent separate entities being part of Soitron Group.



### 2017~2019

In 2017, Soitron Group expanded to Poland by setting up SOITRON POLAND. At the same time, Soitron strengthened its position in the application business by acquiring a majority stake in MILLENNIUM.

In 2018, the two Soitron branches SOITRON SLOVAKIA and SOITRON CZECH REPUBLIC merged together. In both markets the company now operates as **SOITRON** CZECHOSLOVAKIA.

With HP opening a new outsourcing project in Bulgaria, Soitron Group expanded to the Bulgarian market, thus establishing SOITRON BULGARIA in the first half of 2013.

## HISTORY OF THE COMPANY -





In 2014, Soitron Group entered the UK market as well by establishing SOITRON UNITED KINGDOM, its 100 % owned subsidiary based in London.

In 2015 SEKOM TURKEY established a new software house SEKOM YAZILIM.



### 2005~2012

In 2005, Soitron acquired Soitsa shares, thereby establishing itself as a leading IT service provider. A long-term expansion strategy of operation outside the Slovak market was defined. SOITRON CZECH REPUBLIC branch was founded in 2005 and later expanded by acquiring two companies – Caiacom in 2008 and Clarionet in 2009.

In 2009, the biggest Cisco partner in Romania, **DATANET SYSTEM**S, merged with Soitron Group when Soitron Slovakia purchased 51 % of its shares.

In 2012, the biggest acquisition to date was made, with Turkish SEKOM becoming a part of Soitron Group.



### 1991~2004

SOITRON's story started in Slovakia in 1991 when a small company **TRONET** was founded to provide clients with expertise in the emerging world of networking technologies. Over the next 10 years the company grew in size, expanding the number of its customers and employees as well as the depth and breadth of its knowledge.

In 2003, a joint venture between Tronet and Soitsa SA – a Spanish selective outsourcing specialist, was formed to build a large delivery centre for HP in Slovakia under the new name SOITRON.



#### **INTERNAL RELATIONSHIPS**

We all have the right to fair and courteous treatment by our superiors and colleagues. Equal opportunities and equal treatment are key cornerstones of a fair, unprejudiced and open approach.

We strictly prohibit the use of child labor in any form, as defined by applicable laws and regulations. We are committed to providing young workers with a safe and supportive working environment, appropriate training and supervision.

#### **CUSTOMER-SUPPLIER RELATIONSHIPS**

When choosing our suppliers, we apply a transparent selection process seeking nothing other than profitable business from cooperation. Our fairness to suppliers applies to both how we select them and how we work with them. We believe that respecting due dates on invoices is an essential part of a fair partnership.

We are aware of corruption being an important issue and a danger to society, and that is why we have a long-term goal to support any legislative activities aimed at preventing, detecting, and penalizing such behavior.

#### **ENVIRONMENT**

We realize how urgent it is to behave responsibly toward our surroundings and the environment. Our goal is to enable people to act responsibly at work during their working hours and to inspire them to be more responsible and environmentally conscious in their everyday lives. That is why our activities focus on environmental action as well as on raising awareness of responsible behavior more generally.









#### **SOITRON GROUP**

Investments in the development of cybersecurity competencies continued in 2023. This resulted in the 30% year-over-year growth rate in our cybersecurity business. With the aim to continue strengthening our cybersecurity competence, we have taken several measures within Soitron Group.

The cybersecurity company Soitron was spinned-off from Sekom in Turkey. Both companies now represent separate entities within Soitron Group, and changes in the ownership structure were made. Also, global partnership with Palo Alto Networks was acquired and Soitron Group became NextWave Diamond Innovator covering all countries in Central and Eastern Europe in which we operate. We apply a common strategy to address the cybersecurity topics at all markets, resulting in

united methodology to perform security assessments, sharing the expertise, resources and experience.

We have been successfully continued in implementing our MOSY solutions in Moldavia, following the project in Czech republic.

#### **SOITRON (CZECHOSLOVAKIA)**

We have been focusing on the execution of the long-term strategy of double-digit percentage turnover growth in both countries and also gaining new customers. To achieve sustainable growth, we have continued implementing our longterm strategy to develop solutions for cloud environment, transformation to managed services and opening new solutions.

#### **DATANET SYSTEMS (ROMANIA)**

Datanet Systems increased its turnover by 12% in 2023 to €41.7 million, achieving a growth above the sales target and in line with the positive development of the Soitron Group. In terms of technology, 60% of revenues were generated by data network solutions. The sectors with the highest share of turnover were telecommunications, financial services, and the public sector.

#### **SOITRON (TURKEY)**

Cybersecurity spending remained strong against challenging political and economic landscape in Turkey during 2023. Soitron Siber Güvenlik Servisleri (SSGS) grew its revenue by 90% compared to previous year, exceeding EUR 20 million. This growth is mainly driven by company's expanding portfolio of cybersecurity products and services, allowing SSGS to address security needs of organizations at a wider spectrum. In addition, number of SSGS customers increased by more than 30% during the year, being another growth engine for the company.



#### **SEKOM (TURKEY)**

Coupled with the uncertainties over monetary policies and high inflation, investment growth in Turkey rose to 5.1% in the second guarter of 2023 due to strong activity in services and construction and reconstruction efforts after 6 earthquakes in February. On 6 February 2023, a huge earthquake classified as "major" on the official scale at 7.4, hit southern Turkey killing more than 55,000 people with tens of thousands more homeless. Then came the U-turn in fiscal policies after the second round of presidential elections held on May 28, 2023. In the post-election period, the old economic team was largely replaced with officials adopting the orthodox economic approach. The policy rate was increased by 34 percent in 6 months and official annual inflation hit 64,77%.

Sekom teams have extensively collaborated to bring admirable business results in service provider, enterprise and commercial market segments by successfully maintaining in-house knowledge spread across 9 main areas of expertise, namely, Software, DevOps/DevSecOps, Integrated Communications, Data Center, Security, Broadcasting & Cable TV, Service Provider Technologies, SD-X & Cloud and Networking. In line with the expertise of Sekom teams and the increasing work tempo in all market verticals, intensive recruitment was made, and the training of employees was accelerated.



#### MILLENNIUM (SLOVAKIA, CZECH **REPUBLIC**)

Millennium has been part of the Soitron Group for nearly seven years, which has allowed it to grow both in local and international markets. In 2023, Millennium continued to develop the digitalization of the Central European banking sector. The company increased its annual turnover by almost 40% and reaffirmed its position as a strategic partner for major banking institutions. Considering banking institutions to be the leaders of digital transformation, Millennium continued in significant annual investments in need of getting to know and effectively manage its clients.

Millennium has been actively developing a product portfolio in the area of BI/AI. They launched a new product called MILLADA, which makes business, operational, and decisionmaking processes more efficient

by using AI solution ChatGPT. The demand for AI solutions is very high, and Millennium believes that this service will become another relevant pillar of its portfolio.

#### **2RING (SLOVAKIA, USA)**

Contact Centre market is going through a large disruption caused by customers migrating from their legacy on-premises contact centres to a cloud-based platform. Furthermore, customers tend to switch even between cloud-based platforms and thus they are not as loyal as they used to be in the past.

To make sure that customers would be able to preserve 2Ring Dashboards & Wallboards even when the underlying contact centre platform changes, 2Ring is working on adding support for all the major cloudbased contact centre platforms. For

example, towards the end of 2023, 2Ring added support for NICE CXone contact centre platform (in addition to already supported platforms such as Cisco Webex Contact Center, Five9, Genesys Cloud, and Amazon Connect platforms).

The revenue recognized by 2Ring in 2023 was below 2022 and 2021 numbers as a result of transitioning from perpetual model to the subscription-based sales. With a sale of a subscription, a smaller portion of overall sale gets recognized in the first year as the contract value is proportionally distributed through the contract term. It is expected that this transition will also have an impact on 2024 revenue as well while the process of migrating existing perpetual customers to 2Ring Self-Hosted or to 2Ring Cloud Subscription will continue throughout the year 2024 and end by the end of 2025.





#### SOITRON (UNITED KINGDOM)

2023 was a transformative year for Soitron UK, marked by significant expansion and a growing portfolio of partnerships. The team worked with a diverse range of companies, achieving more growth than ever before.

Our collaboration with Cloudpay saw a significant ramp-up, with the team doubling in size to support Cloudpay's ambitious expansion plans. Plutomen, a key partner, further strengthened its relationship with us as we worked together to explore new opportunities using their innovative software. As a critical partner in the testing and development of these apps, we played a pivotal role in ensuring their success.

Our work with Ciena Global Content Networks demonstrated Soitron UK's capability in delivering high-value IT services.

The year concluded on a high note

with the signing of Zempler Bank, in partnership with Content Guru in the UK.

#### **SOITRON (POLAND)**

2023 was our most successful year since entering the Polish market. Revenue grew nearly threefold compared to the previous year, and the result was approximately 40% higher than planned. Financially, we managed to achieve break-even on investments since we decided to enter the Polish market.

In terms of new business, we secured a new contract with Volkswagen in Poznań, where we began providing project management support services (PM and PMOaas). We also started delivering software development and DevOps services for the European Investment Bank.

For 2024, we plan to further develop our collaboration with Volkswagen in Poland, where we have secured a new project in the area of IT support for users.

#### **VOID SOC (SLOVAKIA, CZECH REPUBLIC, ROMANIA, TURKEY)**

In 2023, void SOC not only saw significant revenue growth, but also growth in customer base, with the strongest demand for its services coming from municipalities, the healthcare sector, critical infrastructure and the energy sector. With void SOC services, clients were able to not only respond to incidents effectively, but also increase their resilience to increasingly sophisticated threats.

In 2023, with the support of the European Union, the company launched the development of a next-generation detection platform - SOCulus - that will take clients' cybersecurity to the next level.
